
Statutes of Danish-Chinese Business Forum

Article 1: Name, Objective and Domicile

The name of the Association is Danish-Chinese Business Forum. The registered office is in Copenhagen.

The objective of the Forum is to further commercial and economic relations between Denmark and China with emphasis on the activities of companies in the Chinese market as well as the activities of Chinese companies in Denmark to the benefit of Danish-Chinese Business Forum's members.

Danish-Chinese Business Forum is an executive network association with an informal and direct style of interaction acting in a catalytic capacity. In fulfilment of its purpose Danish-Chinese Business Forum shall promote exchange of information and contacts among companies, organisations, top executives and managers who have Danish-Chinese commercial interests.

The objective of Danish-Chinese Business Forum shall be achieved through a variety of activities organised within the Forum as well as through cooperation with external partners such as private organisations and official Danish and Chinese authorities.

Article 2: Members

Section 1: Admission

Business entities and other institutions may be admitted as members.

Membership applications shall be sent to the Forum's office.

A Committee consisting of the Chairman and the Secretary General decides whether the applicant can be admitted as a member. If an application is not accepted, the applicant can ask the application to be reviewed by the Board whose decision is final.

Members that fail to pay the membership fee can be expelled by the Secretary General after prior consultation with the Chairman.

Section 2: Resignation and Expulsion

Members may resign from the Forum by written notice to the Forum's office no later than 30th September for the resignation to come in effect as per 31st December.

A member may be expelled from the Forum at the Annual General Meeting with two-thirds majority of the votes present if they:

- a) Fail to respect the Statutes, interests or objectives of Danish-Chinese Business Forum
- b) Undertake activities bringing Danish-Chinese Business Forum into discredit

Article 3: Membership Fees

Membership fees are fixed once a year at the Annual General Meeting and are valid for the coming financial year.

The annual fees shall be paid before the 31st March. New members joining after 1st July will pay half the annual fee, and new members joining after 1st October will pay one year's fee, covering the rest of the current year and the following year. In special cases the Chairman may grant an exemption from the payment of membership fees.

Statutes of Danish-Chinese Business Forum

Article 4: Finances and Financial Year

Danish-Chinese Business Forum is a self-financing, non-profit organisation that operates on membership fees and may, in accordance with Board discussion and consent, seek project funding and/or additional financial means from e.g., sponsorships.

The financial year is the calendar year running from 1st January to 31st December.

Article 5: The Governing Bodies of Danish-Chinese Business Forum

Danish-Chinese Business Forum has the following governing bodies:

- 1) The General Assembly
- 2) The Board
- 3) The Secretariat

Section 1.1: The General Assembly

The General Assembly shall be sovereign. It alone shall have the power to decide on the amendments to the statutes.

Section 1.2: Convening the Assembly

A General Assembly shall be convened at an Annual General Meeting at least once in a calendar year.

The Annual General Meeting shall take place no later than the last day of April. The Annual General Meeting shall be called by written notice at least 21 days prior to the date of the meeting.

Section 1.3: The Agenda

The Annual General Meetings shall be conducted by a Chairman elected by the General Assembly.

The Annual General Meeting shall have the following agenda:

1. The report on the activities of Danish-Chinese Business Forum
2. The financial statement for the preceding financial year
3. The election of Board Members
4. The election of a Danish chartered accountant to audit the accounts
5. The setting of the annual fees
6. Proposals from the Board
7. Proposals from Members.

Proposals from the members to be dealt with under item 7 of the agenda and proposals for election of board members under item 3 of the agenda must be submitted in writing to the Board no less than 14 days before the Annual General Meeting.

Minutes will be taken by the Secretariat and signed by the Chairman.

Section 1.4: Voting Rights

All members are entitled to attend the Annual General Meeting, and each member has one vote.

All decisions shall be taken by a simple majority of the votes unless otherwise stipulated in these statutes. Votes may be effected by proxy to a Board Member or another company member but no member may be the bearer of more than one proxy.

Section 1.5: Extraordinary General Meetings

Extraordinary General Meetings may be called by the Board or by 20% of the members and should take place no later than six weeks after a written and motivated request has been filed with the Secretariat.

Section 2: The Board

The management of Danish-Chinese Business Forum shall be undertaken by the Board composed of the Chairman with minimum 6 and maximum 14 other members elected by the Annual General Meeting.

A physical person Board member is always elected as a representative of a member of the Forum, and such member shall during the election term be allowed to replace the Board member with another representative.

If a member of the Forum that has a Board member representative elected terminates its membership of the Forum, such Board member shall vacate the seat at the Board no later than at the time the actual termination takes effect.

In addition, the Board should aim to have appointed Board members from the Danish Ministry of Foreign Affairs, the Danish Ministry of Industry, Business and Financial Affairs, as well as from other public or semi-public organisations that the Board may deem relevant from time to time.

Acceptance of specific Board members appointed by members or public or semi-public organisations, cf. above, shall always be subject to the acceptance of the Board having regard to the best interest of the Forum.

The Chinese Ambassador in Copenhagen will be notified about meetings and invited as an observer when the Chairman finds it relevant.

The election period of the Board members is 4 years. Re-election may take place.

The Board elects the Chairman and one or two Vice-Chairmen among Board members representing the corporate members of the Forum.

Meetings shall be convened when deemed appropriate by the Chairman or called by two Board members. Meetings shall be called in writing including the agenda with at least ten days' notice.

Resolutions shall be passed by a simple majority and the Board will be considered a quorum if 50% of the members are present. In case of a tie the Chairman has the casting vote.

The Board may name a Patron who can promote the Association and increase its standing.

Section 3: The Secretariat

The Board may hire the necessary staff to ensure the daily management of Danish-Chinese Business Forum.

The secretariat is headed by a Secretary General. The Secretary General has the sole responsibility for the day-to-day management of staff. The Secretary General reports to the Board and shall participate in the meetings of all bodies of Danish-Chinese Business Forum.

The Board may issue instructions to the Secretary General on the conduct of the Forum's business.

Article 6: Signatures and Liabilities

Danish-Chinese Business Forum shall be bound in all legal transactions by the joint signatures of the Chairman and the Secretary General or the Secretary General and two members of the Board. The Board can authorise a member of the Danish-Chinese Business Forum secretariat to sign for Danish-Chinese Business Forum per procurement.

Article 7: Amendments, Mergers and Dissolution

Amendments to the Statutes, a merger with another institution, or the dissolution of the Forum can only be approved by the General Assembly where at least two-thirds of all members vote in favour.

If a majority of the General Assembly votes in favour of the proposal but do not make up two thirds of all members, the Board may convene an Extraordinary General Meeting. The proposal can be approved at the extraordinary meeting by two-thirds of the members in attendance.

If a dissolution of the Forum is adopted, the General Assembly shall decide how the funds of Danish-Chinese Business Forum should best be applied in accordance with the objective of the Forum.

Article 8: Arbitration

All disputes regarding the interpretation of these statutes shall be decided by arbitration set up by the International Chamber of Commerce - ICC Denmark.
